(Consortium in any form will not be permitted, if any consortium do exit, their respective applications will be summarily rejected)

Interested Agencies should submit online bids **FOR APPOINTMENT/EMPANELMENT OF AIR TRAVEL AGENCY FOR ENTERTAINMENT SOCIETY OF GOA” AND FOR 53<sup>rd</sup> INTERNATIONAL FILM FESTIVAL OF INDIA (IFFI), 2022.** The Applicant is requested to sign and upload all the documents comprising Technical Bid, Financial Bid and all the Annexure attached.

The Agency is requested to quote rates in the 'Financial Bid' keeping in view the terms and conditions of this Tender Document and the tender is liable to be rejected if any change in the terms and conditions is proposed. The Applicant has to submit **Earnest Money Deposit of ₹ 6,50,000 /-**(Rupees Six Lakhs Fifty Thousand Only)**through**

- National Electronic Fund Transfer (NEFT)/ Real-Time Gross Settlement (RTGS). Applicant is required to download pre-printed Challan towards credit of ITG available on e-tender website and make its payment through any of their Bank.
- Net Banking: Payment can be made via Internet Banking facilities. Any payments made through NEFT/ RTGS will take 24 hours for reconciliation. Hence the payments through NEFT/ RTGS should be made at least two bank working days prior to the deadline. The respective challans must be uploaded.
- Payment via Cheque/DD will be deemed rejected.
- Tenders without the Earnest Money Deposit (not in compliance with the above mentioned processes only) will be deemed rejected.
