Terms and conditions

1. Application Forms will be accepted till 3.00 pm on 7/11/2022.
2. For any dispute, ESG shall be the final authority and its decision shall be final and binding. ESG reserves all rights to accept or reject or cancel any or all EoI/proposals in part or full without assigning any reason thereof.
3. The agency shall submit the Demand Draft drawn in the favor of “Entertainment Society of Goa” along with the application.
4. The EOI/Proposal shall be submitted in a sealed envelope super subscribed as “Expression of Interest/ proposal for Setting up of stalls for 53rd IFFI 2022”.
5. The vendor will be provided with a stall of size 10ft x 10ft at Inox Courtyard / corniche area.
6. The submission of bid, above or equal to the minimum reserved price doesn't guarantee the allotment of stall.
7. In the Entertainment Zone (Nr. Art park), the stall has to be setup by the applicant in the allotted space of 10 ft x 10 ft.
8. Use of gas cylinders on any stalls is strictly prohibited. However electrical appliances can be used for cooking. Such as oven, induction, hot plate, etc.
9. FDA/any other necessary license should be taken care by the agency.
10. Past IFFI participation will be taken into consideration.
11. The stall/ stall space will be allotted based on first come first serve basis by ESG.
12. The allotment of stall will be based on the highest bid received. In case of more than 1 entries of the same bid amount, the stall shall be allocated through picking of lots.
13. Garbage should be managed by the agency / stall owner.
14. Only one stall will be allotted per application.
15. No sponsorship should be raised by the agency / stall owner.
16. Dishes / beverages to be served in disposable or eco friendly products.
17. Incomplete Applications are liable for rejection.
18. The decision of the ESG will be final and binding.
